1. Project Background and Description

Jackson County Public Schools in North Carolina is accepting proposals for PER-UNIT PRICING on six hundred fifty (650) "Shape the Future" (https://www.microsoft.com/en-us/education/products/windows/shapethefuture.aspx) eligible Windows 10 student devices.

JCPS recently received confirmation that funding for the Digital Learning Initiative has been renewed for the 2020-21 school year. As a result, JCPS intends to purchase new devices for students in grades 7 and 10. Since funding for the Digital Learning Initiative is provided on a year-by-year basis, no multi-year contract will be considered.

The approved productivity platform for JCPS is Office 365, and the standard operating system is Microsoft Windows 10. All JCPS classrooms are equipped with high-density wireless access points, and all nine JCPS schools are connected to the central office via a 10Gb fiber optic network.

2. Project Scope

Upon completion of this bid process and the approval of the winning proposal by the Jackson County Board of Education, JCPS intends to purchase 650 Windows 10 "Shape the Future" eligible devices for distribution to students in grades 7 and 10. The actual quantity may vary more or less depending on the final cost.

JCPS will choose a winning vendor based on "best value" and most advantageous to Jackson County Public Schools. OEM's are encouraged to provide resellers with "first-preferred vendor" pricing for this project. Following approval of the winning proposal, a purchase order will be issued to the winning vendor as soon as possible.

All of the devices must be delivered to a single location at Smoky Mountain High School located at 100 Smoky Mountain Drive, Sylva, NC 28779. There is no loading dock at the delivery location, so the delivery vehicle should be equipped with a lift gate if it is a large truck.

Deadline: Friday, April 24th at 4:00 PM

The winning vendor shall:

- Have previously secured a purchase contract of similar size and value.
- Have been in the business of selling computers for a minimum of three (3) years.
- Provide upon request three (3) references from current customers that have made volume purchases similar in scope to this procurement. Each reference must contain the point-of-contact's name, physical address, and telephone number.
- Identify the names and contact information for any individuals assigned the responsibility of handling this account.
- Be the manufacturer, or authorized to purchase products directly from the manufacturer, or a reseller authorized to purchase from a distributor that is factory-authorized to purchase products directly from a computer manufacturer.
- Be the manufacturer or certified by the manufacturer of the item(s) to provide warranty and/or repair on the equipment included in the proposal.
- . Bids that cannot meet the delivery deadline will be scored according in the evaluation matrix.
- Describe in detail any applicable self-maintainer or warranty.
- Provide only OEM power bricks and power cords.
- Etch all devices with the JCPS logo.
- Ship all devices and accessories to:

- Ensure the delivery vehicle is equipped with a lift gate if it is a large truck.
- Include Shipping cost in bid
- Include cost of etching device in bid
- Include cost of all White Glove services listed in bid.
- Include an estimated amount of time from receipt of PO to fulfillment of the order.
- Consider any shortages of parts that might affect the ability to meet the shipping deadline. Include an explanation in the bid packet.
- Hold devices in their warehouse until July 6th. (We would like to have them delivered as close to this date as possible)

3. Device Specifications/Minimum Requirements

White Glove Service

- Add asset sticker to device, including Linear Barcode (code 39 or code 128)
- Record Computer Name, MAC, Serial and Asset in a spreadsheet

- Laptop must come with our JCPS Windows 10 image on the device
- Add the device to the JCPS active directory domain using a site-to-site VPN
- Assign each device a unique Computer Name, in our format STUXXXX-5001
- Prefer unboxed, if devices can be protected during delivery
- Do NOT deliver devices before July 6th. Hold in your warehouse until then.

Extra Power Supplies

- Provide cost per unit for extra power supplies. This price must be honored for 12 months from RFP award.
- Currently JCPS has extra power supplies in every 1:1 classroom.
- USB-C preferred, Lenovo Slimtip also accepted

USB to **Ethernet Adapters**

• If the device does not include a built-in Ethernet RJ45 connector, please provide the cost for USB to Ethernet adapters. We will need to have 10% of the total units purchased in adapters. IE: if 650 units are purchased, we will need 65 adapters. This will be included in the Evaluation Unit Price Criteria. Must be able to image and PXE boot from USB-to-Ethernet adapters using Microsoft MDT and Microsoft WDS.

4. Evaluation Criteria

This is a "BEST VALUE" procurement, and, as such, the award will not necessarily be made to the vendor submitting the lowest price. Instead, the award will be made to the vendor submitting the best responsive proposal that is most advantageous to Jackson County Public Schools.

The following pre-determined criteria will be used to evaluate and score the proposal for each individual model. If the proposal for either model is disqualified, it will not disqualify the entire proposal.
