1. Project Background and Description

Jackson County Public Schools in North Carolina is accepting quotations for Promethean ActivPanel TVs.

JCPS has standardized on Promethean as our Interactive TV vendor in our classrooms. Currently all classrooms have a Promethean product and about 40% of our classrooms have been converted from the ActivBoard technology to the ActivPanel technology. JCPS is looking for a vendor to purchase at least 40 ActivPanels and some carts. Some additions to the quantities might happen before the order is placed.

Quotations are for the product only. We will be installing the panels ourselves.

Deadline: Monday, March 1st at 4:00 PM

2. Project Scope

Upon completion of this bid process and the approval of the winning proposal by the Jackson County Board of Education, JCPS intends to purchase at least 40 Interactive TVs.

JCPS will choose a winning vendor based on "best value" and most advantageous to Jackson County Public Schools. OEM's are encouraged to provide all resellers with "first-preferred vendor" pricing for this project. Following approval of the winning proposal, a purchase order will be issued to the winning vendor as soon as possible.

All of the devices must be delivered to each school location. There is no loading dock at the delivery locations, so the delivery vehicle should be equipped with a lift gate if it is a large truck.

The winning vendor shall:

- Have previously secured a purchase contract of similar size and value.
- Have been in the business of selling Interactive Classroom equipment for a minimum of three (3) years. Include a verification statement in the proposal that confirms the number of years the vendor has been in the business.
- (3) references from current customers that have made volume purchases similar in scope to this procurement. Each reference must contain the point-of-contact's name, physical address, and telephone number. (at least one contact should be a school system.)
- Identify the names and contact information for any individuals assigned the responsibility of handling this account.
- Be the manufacturer, or authorized to purchase products directly from the manufacturer, or a reseller authorized to purchase from a distributor that is factory-authorized to purchase products directly from a manufacturer.
- Be the manufacturer or certified by the manufacturer of the item(s) to provide warranty and/or repair on the equipment included in the proposal.
- Bids that cannot meet the delivery deadline will be scored according in the evaluation matrix.
- Describe in detail any applicable self-maintainer or warranty.
- Ship all devices and accessories to the school locations. Included in Appendix A
- Ensure the delivery vehicle is equipped with a lift gate if it is a large truck.
- Include Shipping cost in bid
- Include an estimated amount of time from receipt of PO to fulfillment of the order.
- Consider any shortages of parts that might affect the ability to meet the shipping deadline. Include an explanation in the bid packet.
